Comments: The inspector noted that the facility did not meet the requirement of at least 50% of educators holding a one-year Early Childhood Education Certificate or equivalent. The administrator confirmed that one staff member is currently enrolled and scheduled to begin the program in September 2026.			
41(3) An operator of a licensed facility shall (b) ensure that a child is never left unattended during diaper changing.	41(3)(b)	Aug 31, 2026	Aug 31, 2026
Comments: The Quality Assurance Monitor observed that a child had climbed onto the changing table without assistance while an educator was occupied supervising other children washing their hands. The QAM proceeded to the changing area while notifying an educator nearby in the classroom. The educators immediately went with the child. Deficiency is now compliant.			
49(1) An operator of a licensed facility shall ensure that the guidance of the children receiving services at the licensed facility is positive and includes positive reinforcement, encouraging efforts and recognizing accomplishments.	49(1)	Jun 08, 2026	Aug 31, 2026
Comments: The after-school children went downstairs to play freely while the other children stayed upstairs for nap time. The afterschool children were not required to stay in their cot. Deficiency is now compliant.			
49(2) An operator of a licensed facility shall ensure that no child receiving services at the licensed facility is subjected to any form of physical punishment or verbal or emotional abuse or is denied physical necessities.	49(2)	Jun 08, 2026	Aug 31, 2026
Comments: The inspector observed that the children were not denied any essential necessities. Deficiency is now compliant.			

General Comments

The Inspector and the Quality Assurance Monitor (QAM) were on site during the morning, including outdoor

play, lunch, and nap time periods. Educators were observed sitting with the children at the table during lunch.

Towels were observed stored in a corner of the stairwell. As traffic areas must remain free of obstructions and hazards, the administrator was asked to remove the towels and did so immediately.

The Inspector observed that preschool and school-age children who were not sleeping had access to a play area downstairs under the supervision of one educator, while the children who were resting remained upstairs with another educator. This allows children to engage in quiet play while ensuring that everyone's needs are respected.

Two applications for changes forms must be sent to the licensing department; those applications were discussed while on site.

The ratio was respected during the visit.
