General Comments
<p>Licensing Staff Lindsay Lewis and Hannah Mitchell arrived at the facility to conduct a Monitoring Inspection. Upon arrival, all classes were in the process of transitioning from nap time to afternoon snack. Hands were observed being washed before the children sat at the tables to eat. Today for snack the children had banana bread and milk, which matched what was posted on the menu.</p> <p>In the 4-year-old classroom the children have been interested in Valentine's Day. Valentine's Day webbing was observed on a large whiteboard near the library/cozy corner. As the children finished snack some were observed reading books while others played with playdoh and a Fisher Price Corn Popper. In the 2-year-old classroom children were observed playing with two sensory bins which were filled with colorful rice, pasta, pompoms, plastic gold coins and colorful wooden craft sticks. While the children waited for a turn playing with the sensory table some looked through story books and others played with vehicles. The children were eager to show Licensing Staff their family pictures which were displayed at the back of the classroom.</p> <p>In the 3-year-old class, the group was observed gather together to sing "Head, Shoulders, Knees and Toes." followed by the book "Shapes with Blue." The Educator engaged with the children as she read the story. The room had a variety of learning resources and play materials available on low, open shelving. A large map titled "Our Walking Map" was displayed on the wall along with photos of local stores and restaurants. In the Senior Infants classroom new foam climbing blocks have been added to the indoor environment. The Educator stated the infants have been exploring and enjoying the new added materials.</p>

General Comments

Positive child guidance was observed during today's Monitoring Inspection. Staff files were reviewed during today's Monitoring Inspection. The files were easily accessed and contained all required documents. A list of allergies was posted in each classroom and in the kitchen. A conversation was had with the administrator regarding the importance of Educators knowing how many children are present in the classroom at all times. Webbing and planning sheets were observed in each classroom. Please ensure planning sheets are dated.
