General Comments
<ul style="list-style-type: none"> -Early-morning visit to the establishment for an unexpected monitoring inspection -During the visit ratio was respected in a mixed age group and a same age group -Work was done in the indoor play area, it is now safe and clean - Material and equipment proposed to children are easily accessible on low, open shelves. It is varied and in sufficient quantity for all children present. -Three books explaining loose parts were borrowed so that the operator may get an idea of what is possible when it comes bringing loose parts into her center. An email will be sent to her pedagogical consultant to see if support can bring to assist the operator to have more open-end material into her space. -A changing pad is used for diaper changing, it is close to the washroom in the hallway -The changing pad needs to sanitize between each diaper change, the operator will get a sanitizer, and was explained that it will need to be put out of reach of the children but accessible to her. -The changing pad needs to be covered with a non-absorbent layer, suggestion was made to the operator on what to use has a cover. -Diaper changing is done separately from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing. -Diaper changing necessities need to be stored separately and easy to access for each child that is not potty trained, suggestion was made to the operator

General Comments

-It was suggested to have either a hand towel or hand paper accessible to the children for them to wash their hands.
-It was asked to put away room parfums because it was at children's reach.
-During the visit, it was observed that the operator is engaged with children. She brings herself at their level providing support and having conversations.
-It was discussed with the operator on how things are going with the scheduling of her day, with the infant sleeping twice a day, we've discussed alternative on how she can meet all kids needs with sleeping, eating and proposing activities for all ages.

Observations: When arriving at the center children were eating their snack, they then transitioned to free play, when leaving the infant was getting ready for a nap.
