General Comments
<ul style="list-style-type: none"> -Early-morning visit to the establishment for an unexpected monitoring inspection -Ratio was respected during the visit -The daily information sheet for infants (0-24 months information about the child's mood, eating schedule, rest time, diaper changing) is completed every day and stored in the child's file. Copies of the daily information sheet was given to the operator. -Procedure for diaper changing was reviewed with the operator, the hand-washing of the children after the diaper change was emphasize -Four children's files out of six have the required documents, except 2 files are missing Medicare number and expiration date. Confirmation will be sent by email to licensing staff, once the required information is into the children's file. -During the visit, it was observed that all educators are engaged with children at their level providing support and having conversations. -Within the home base setting the room next to the play area is designated for nap time. Each child has a designated cot and a crib for infants (0-23 months) are also within the room. The operator confirms that the sheets and blankets are sent home to be washed weekly. -There is a space of at least 46 cm between rest equipment and all nap equipment is washable and non-absorbent -It was discussed with the operator that the preschool kids who don't nap can have a quiet period for 30 min and then get back to their regular schedule. -Toxic products, and cleaning supplies are locked under key and are inaccessible to the children -No firearm is kept in the family dwelling. -Small objects (corks, wooden pebbles) in the loose part section are now stored out of reach for infants. It was explained to the operator that smaller objects may be taken out for the infant to play with when she is sitting next to the infant providing direct supervision.

General Comments

-Operator confirms that the monthly emergency evacuation and fire drills have been done during the month of September. Operator confirms that a meeting point is set, and parents were made aware of it into their parent's handbook, and it is posted on her parent's board.

Observations: When arriving at the center, some children were eating their breakfast or snack. They colored, looked into books and showed me around their play area.
