- Visit completed at the facility in the morning for a monitoring inspection.
- During the visit, the ratio was respected.
- Posted at the entrance of the facility are the following documents. The licence, inspection report, orders for compliance, daily routine, evacuation procedures, name of administrator, name and telephone number of QA Monitor and inspector Life threatening allergies and when it applies a notice to inform parents of the existence of a communicable disease.
- The center provides purposefully planned and documented programming that ensures children have: Time and space for free choice of play experiences. Indoor and outdoor opportunities for physical activity, both individually and in groups. Literacy experiences and chances to express creativity and personal interests. Opportunities to explore the arts and sciences, fostering curiosity and discovery. Experiences that promote accomplishment and success, building confidence. Chances to problem solve and develop critical thinking skills. Opportunities to build trusting, respectful, and supportive relationships with peers and educators. Learning stories are seen in all rooms.
- The diaper changing station is found in the washroom. The diaper changing station is located one metre from a sink. Children are always supervised during diaper changing.
- Signed consent forms are obtained from the parent/guardian before administering acetaminophen to a child. The consent form is filed in the child's file. Medication for anaphylactic shock is easily accessible in case of emergency and stored safely and out of reach of children. Prescribed medication is clearly labelled with the Doctor's name, instructions for use and the time period for administration. Non-Prescribed Medication is in the original container with the child's name and dosage clearly indicated. Medication is locked in the kitchen and inaccessible to children.
- Observation:
- 2-3-Year-Olds:

During the visit, outdoor play, diaper changing, handwashing, free play activities, and lunch were observed. During free play, the children engaged with dinosaurs, cars, and block-building activities. The educators were actively singing with the children.

4-5-Year-Olds and Afterschoolers:

The children returned from outdoor play, washed their hands, participated in free play activities, and then had
