Comments: The 4-year-old room was closed off as staff were preparing for graduation; therefore, kids did not have access to their materials.

Comments: The diaper changing procedures are not posted in the diaper changing area. These need to be posted.			

<p><b>General Comments</b></p> <p>Mid morning visit to complete renewal inspection. Ratio was respected at time of visit.</p> <p>Discussion was had with educator in the 4 year old room in regards to rest time. Children who do not nap are not required to rest, but they may play quietly. Children who do not rest the entire time are allowed to get up and play quietly or join other children who are not resting. A separate space is provided for children who do not nap, so they do not disturb resting children.</p> <p>Upon arrival, preschool children were playing in the outdoor play area. They then came inside, where handwashing and diaper changing (as needed) took place. The children proceeded to have lunch. Following lunch, most children napped. Those who did not nap participated in quiet activities such as art and reading. No school aged children were present at time of the visit.</p>
