General Comments

Licensing staff arrived at the home at 8:30am. Upon arriving, the operator and the children were observed playing outside. The operator greeted the Quality Assurance Monitor and was observed engaging with the children while at play. The children played on the play structure, bikes and in the sand. The children had access to sand digging accessories such as buckets and shovels. The outdoor play area was equipped with a variety and sufficient amount of outdoor play materials such as water tables, mud kitchen with pots and pans, play structure, slip and slide and a dramatic play BBQ with accessories. The operator was observed engaging in free play activities while supervising the children. The operator was heard encouraging the children to stay within the tree line boundary.

The operator was heard asking the children if they were cold and decided to transition inside and the wind was picking up. The children and operator were observed transitioning inside the home. Once inside, the children took their shoes off and the operator placed the children's personal belongings on their hooks near the door. While inside, the children were observed playing in the indoor "playroom" a variety of indoor play materials were observed such as toy animals, action figures, books, musical instruments, large Legos, a sensory bin and plush toys. The operator was attentive to the children and ensured that the infants had access to play materials. The operator was observed setting out large blocks and magnetic tiles for the children to engage with.

Later, the operator was observed transitioning to the living room. A sensory bin invitation was prepared for the children. The operator was observed sitting on the floor while playing with the children. As the infants appeared to lose interest, the operator was observed setting out playdough and accessories for the younger children. The operator was heard encouraging the children to share resources and observed helping them resolve conflicts. Later, snacks were served to the children. Please remember to wash the children's hands and sanitize the tables before serving snacks and meals. The children were supervised while they ate.

After eating, the children returned to free play activities such as drawing and playing with the "ocean board". The operator was in touch with the children's needs by wiping their noses and offering snacks. A conversation was had with the operator about organizing the indoor play area with shelving and defining curriculum areas. Licensing staff recommends encouraging the children to help clean up their activities before moving on to

another activity. Having labels on bins and or shelves would allow the children to recognize where toys should be stored. A conversation about pre-planned activities and documentation of the children's learning was had with the operator. The Quality Assurance Monitor recommended webbing and taking pictures of the children while at play for documentation and learning stories.
