<p>General Comments</p> <p>A monitoring inspection occurred in the morning.</p> <p>The child was observed in the indoor and outdoor environments, as well as during transitions between the two. Upon arrival, the Operator was outside with the child in attendance and engaged in a variety of activities, including blowing bubbles, water play with a fishing net, trucks and containers, and playing in the outdoor play kitchen.</p> <p>Indoors, the child was observed using play dough alongside the Operator, drawing, playing with trucks, and eating a snack. Additionally, a diaper change was observed, and diaper changing procedures were followed appropriately.</p> <p>Several forms of documentation were visible throughout the home, including photographs, individual learning story books, and children's artwork. The rooms were well organized and inviting, offering a varied supply of age-appropriate materials, books, and toys.</p> <p>The Operator demonstrated positive interactions by using encouraging language and providing gentle reminders when needed. The Operator asked open ended questions, actively listened to the child's responses, and extended the child's ideas through meaningful conversations.</p> <p>A clearly visible and prominent area was designated for the posting of the facility license, current monitoring reports, and any orders for compliance. Additional documentation reviewed included incident logs, daily attendance records, daily information sheets, three child files, and records of evacuation and monthly fire drills.</p> <p>A conversation took place with the Operator on the following:</p> <ul style="list-style-type: none"> • Ensure the time required to evacuate is documented for each fire drill conducted. • Ensure all children's files contain the required two emergency contacts. • Ensure the locked closet containing toxic products always remains locked and is inaccessible to children.
