General Comments

Indoor environments have a variety of materials within each interest centre that encourage children to engage in play and exploration.

Educators observed engaging in meaningful conversations with the children at their level. Each environment has a variety of documentation displayed that supports the children's learning, experiences and emerging interests.

A variety of loose parts have been added to the outdoor environment. Opportunities for mark making, creating, building, gross motor development and exploration of nature are accessible to all children during outdoor play.

Homemade beef and vegetable soup and fruit was served for lunch. Diaper changing routines observed and procedures were followed. Random review of staff files and children's files - all files complete. One EpiPen on site is expired, discussed with administrator during inspection. New EpiPen to be added.
