Comments: While observing the outside play area, it was observed that the pea gravel surfacing under the swings, was worn down. The surfacing under the swings was minimal, due to the number of children swinging during the school day. A conversation took place with educators regarding surfacing. Before the afterschool children are able to resume using the swings, educators are to ensure that there is enough surfacing. Educators to move some of the access surfacing, under the swings.

Comments: White-out was observed on a low shelf. Toxic products must be locked in separate storage areas. Bingo dabbers were observed on low shelf. Bingo dabbers must be stored out of reach of the children. Educators corrected on site. Deficiency is now compliant			

General Comments

A Monitoring Inspection occurred June 9, 2025

Children were observed in the indoor and outdoor environments.

While inside, children were observed engaged in dramatic play, drawing self-portraits, playing with a doll house and dolls, reading and doing a puzzle. Educators stated that the current interests of the children is "Under the Sea. Evidence of this interest was displayed around the room through salt paintings of the sea and a group under water painting mural. The group also created the following animals with several varying materials' octopus, starfish, and turtle.

Outside the children were observed playing soccer, wall ball, and playing on the playground. Children applied sunscreen before going outdoors. Water bottles were filled up and available to the children playing outside.

Several pieces of documentation were observed throughout the room and hallway that included children's art, child print, and photos.

General Comments

The following documents were observed, incident logs, daily attendance, evaluation and monthly fire drills and 1 new staff file. The license, inspection and monitoring reports, and compliance orders are posted.
