| <p>A Monitoring Inspection occurred July 2025.</p> <p>Parents and children are greeted with enthusiasm upon arrival.</p> <p>The children were observed in the indoor and outdoor environments, as well as transitioning to the outdoor play yard.</p> <p>Frog Room: The children were observed transitioning from the play yard to indoors to have snack. Handwashing occurred before eating. The educators indicated that the children are currently interested in summer, such as ice cream and the beach. Outside the children were observed digging, participating in dramatic play (making cakes for educators), and mark making.</p> <p>Monkey Room: The children were observed playing with new trucks and superhero figurines, puzzles and doing open ended art. The educators indicated that the children are currently interested in gardening. Documentation showing the recent vegetables the children had grown was observed.</p> <p>Dolphins- The children were observed eating snack on the picnic table outdoors. After snack children transitioned to free play. The educator indicated that the children are currently interested in climbing, playing with trucks, going down the slide and going on walks.</p> <p>Bees and Duckie Rooms: The children were observed playing connect 4, mark making with chalk, and blowing</p> |

bubbles. The educators indicated that the children are currently interested in bubbles, art and going on walks.

Turtle Room: The children were observed transitioning from the classroom to outdoors for a walk.

All rooms were set up with materials that invite children to play. Well defined learning and play areas were observed, and several pieces of the children's artwork were displayed throughout the facility. Daily routines are posted in each room.

A clearly visible and prominent place is available to post the license, current monitoring reports, and orders for compliance. The following documents were observed, incident logs, daily attendance, evacuation and monthly fire drills and two new staff files.

Toxic products such as chemical products and cleaners are locked and inaccessible to the children.
