<p>General Comments</p> <p>A Monitoring Inspection occurred on April 9, 2025.</p> <p>Children were observed during free play indoors and outdoors and the transition to lunch. Proper handwashing was observed. All sinks had stepstools and were accessible.</p> <p>Educators discussed the children's interests. Children are exploring the properties of local animals such as squirrels, engaging in physical outdoor play in the snow, planting flowers in painted pots, and finding ways to express themselves through art experiences.</p> <p>Daily incident log is completed and maintained. Staff to child ratio was observed as compliant. Infants were not mixed with other groupings of children. Incident log was maintained, parents are aware of incidents and sign the daily log. Indoor areas and trafficways were maintained safe and clean. Children were observed outdoors, weather permitting are playing outdoors for one hour every four-hour time block. Observed a variety of learning centres based on the children's interests, such as a salon, areas for art exploration, dramatic play zones, a fish tank for exploration as well. The facility has a wide range of books displayed based on the children's interests. Art was observed throughout the centre.</p> <p>Invitations were observed ready for exploration, there was a variety of documentation such as learning stories,</p>

webs and photographs, a visual schedule that document the planning process and the emerging interests of children and educators.

A conversation occurred with the Administrator on the strengths and needs of the facility. The strengths of the facility are the variety of documentation, children's portfolios are updated and accessible to the children and there are multiple handmade books and materials made for the children by educators. The needs discussed related to spring cleaning activities in the outdoor yard, dusting of indoor surfaces, behind the fireplace screen and on tops of surfaces.
