| <p>General Comments</p> <p>A monitoring inspection was conducted today. Educators and children were observed indoors and outdoors.</p> <p>In the outdoor environment, children were observed engaged in a variety of activities including parachutes, slides, and balance beams. Educators were observed engaged in conversation with children as they played. As children spend more time in the outdoor play area, consider how materials from the indoors can be set up as invitations for children in the outdoors to build on current interests and expand learning.</p> <p>Ensure wood chips are raked daily around the slide. Documentation of children's learning was posted in all rooms, highlighting interests, activities, and milestones. In the toddler room, it is recommended that some documentation be displayed at the children's level to provide a sense of self, other and belonging for the children in the room.</p> |
