General Comments

The children were observed during outside morning play, snack, lunch, and quiet/nap time.

Handwashing was observed occurring after outside play, have diaper changing, washroom breaks, and before snack and lunch.

Observed in the 2/3-year-old room an Educator hanging pieces of fabric over the windows and securing them with tape during nap/quiet time. Recommending that either blinds or curtains be installed to help make the room

Proper diaper changing procedures were also observed occurring.
