Comments: Several books were in disrepair. Administrator to complete a walkthrough of all rooms, observe all books, and repair / replace books in need.						
General Comments						

A Monitoring Inspection was conducted this morning. Upon arrival, children were observed playing in the outdoor fenced in play area. Parents were observed dropping their children off and educators were observed signing the children in, on the government issued attendance forms. While outside, children were observed searching for bugs, building with wooden logs, digging, and playing with Tonka trucks. Children were observed transitioning from outside to inside. Handwashing procedures were observed, upon entering the building. Children were observed sitting at their tables, eating snack. A conversation was had with administrator regarding the state of some of the children's books. It is evident that children have been enjoying their books, however, several books are in disrepair. Administrator stated that they would swap out the books in disrepair with newer books. A conversation was had with administrator regarding the accessibility of glue and scissors in the 2/3 room, as well as downstairs, in the preschool room. Both items were available, but not directly accessible to the children. These items are to be accessible and available to the children. One idea that was discussed, was to store these items in see through containers with lids, and have these containers accessible to the children, on lower shelves, in the arts and crafts centers. Several forms of documentation were observed throughout the facility - word webs, children's artwork, photos, etc. Several well-defined play centers were observed in each room - building, arts and crafts, loose parts, dramatic play, dinosaurs, books, etc. Positive child guidance techniques were observed - educators anticipating children's needs, educators understanding child development, educators preparing children for transitions, and educators using positive language when interacting with children.
