<p>Comments: 2's - while outside, attendance records were inside. Attendance records are to be taken out of the facility whenever children leave the building. When children are in the outdoor play area or on outings, staff members are to have copies of the attendance records with them.</p> <p>4's - while outside, attendance records were inside. Attendance records are to be taken out of the facility whenever children leave the building. When children are in the outdoor play area or on outings, staff members are to have copies of the attendance records with them. If a classroom is split into groups, and if one group is inside, and one group is outside, attendance records must reflect this. In this case, each group would require an accurate attendance form, reflecting all children present at any given time.</p>			

<p>General Comments</p> <p>A Monitoring Inspection was completed this morning. The infants were observed inside their classroom. Educator was observed reading to a group of infants. After story time, infants were observed holding on to, and looking at their own books. The 2's were observed both inside and outside. While inside, children were observed sitting together, listening to their educator read a story. An educator was observed helping with toileting, and handwashing procedures were observed. While outside, the 2's were observed running and laughing, riding toy vehicles, and playing in the play kitchen area, making cookies. The 3's were observed outside. While outside, the 3's were observed riding toy vehicles and playing chase. Educators stated that the 3's are presently interested in dinosaurs, Lego, dressing up, and Halloween. The 4's were observed both inside and outside. Inside, the 4's were observed looking at books and playing with dinosaurs. Educators stated that the 4's are presently interested in dinosaurs, fossils, books, and arts and crafts. While outside, the 4's were observed sliding on the slide, and playing in the mud kitchen, making cookies.</p>
