Children from the "Oatmeal Room" observed exploring loose parts in the outdoor play area this afternoon. They were engaged in making "food" for a Baking Competition. How can you document this interest? What materials

The "Blue Room" is set up in a way that invites children to explore materials and engage with their peers. Purposeful planning is evident through documentation, invitations and materials added to the environment. The children in this group have been exploring sewing, hiking, animals and items from nature.						
Children in the "Purple Room" were observed during snack time and story time. Children are currently required to eat snack all at the same time at assigned seats. How can you make snack time more flexible? Documentation is posted throughout the environment that supports the children's current interest in bugs. Discussed with educators the use of pre-planned crafts. Art is to be open-ended. Challenged educators to focus on setting up open-ended art invitations to see how the children create and explore art materials.
