<p>General Comments</p> <p>Renewal Inspection:</p> <p>A renewal inspection was conducted in the afternoon with the school-aged children. The children were observed arriving from school and washing their hands upon arrival at the center before proceeding outdoors.</p> <p>During outdoor play, the children were engaged in a variety of activities including blowing bubbles, playing catch, swinging on tire swings, coloring, building forts using tires and wood, digging for worms, and playing soccer. The educators were observed actively supervising the children and were positioned throughout the outdoor play area to ensure proper oversight. The educators were also engaged in play and meaningful conversations with the children.</p> <p>Purposeful planning was evident through documentation displayed throughout the environment, including photos, webs, and written observations. Current learning topics include worms, squirrels, sports, musical instruments, and structures.</p> <p>Monthly fire drills are documented. Daily attendance records were reviewed and reflect all children present. Child-to-staff ratios were observed to be met at the time of inspection. All required documentation is posted on the parent board.</p> <p>All staff files were reviewed, and a random review of the children's files was completed.</p> <p>The following items were discussed with the on-site administrator: Blue Room: One incident log had not been signed by staff. Educators must ensure incident logs are signed upon completion. The carpet in the back reading area is fraying along the edge and must be repaired or replaced. Purple Room: One Administration of Medication form was posted on the wall. These forms must be stored in a confidential location to prevent a breach of sensitive information.</p>
