After snack, children were observed in their cozy reading corner, looking at books. Educator was observed reading a story to the children. Educator stated that children

are presently interested in "Bear Hunting" games, playing outside, and going on walks, especially to the Library. 4/5 Room - Children were observed washing their hands before snack. After snack, children went for a walk. Several forms of documentation were observed throughout the facility (word webs, children's artwork, photos, etc.). Well defined learning centers and invitations were observed in all rooms (Arts & Crafts, Building, Dramatic Play, Science, Cozy Reading Corners). Educators were engaged with the children - using positive language when interacting with the children, being on the children's level, conversing with the children, offering choices, and anticipating children's needs.
