## **General Comments**

Monitoring Inspection COVID-19 Recovery Phase:

Children engaged in outdoor play this afternoon. Positive interactions observed between educators and children.

Environments have been rearranged into two groups; each group has their own entrance/exit, washroom, indoor play area and outdoor play area.

It is evident staff have been frequently cleaning play area, high touch areas, washrooms and toys. A cleaning schedule has been created and is implemented well.

All toys that are not easily cleaned have been removed. Each child has their own art supply pouch and bag of Lego in their cubby.

Hand washing routines were observed today.

General Comments					
Ensure that First Aid Kit and attendance are brought outside to the outdoor play area. This can be a smaller First Aid Kit that is stoked with frequently used First Aid supplies. See section 10.8 of Operator's Manual under what you need to know.
