General Comments

Monitoring Inspection:

During monitoring inspection today it was discussed with the educators the importance of ensuring that anyone entering the facility be asked the COVID-19 questionnaire and have their temperature taken and the information recorded. Also discussed morning groupings and that the "bubble" groups must be separated at all times even early morning.

Educators had questions regarding "risky play". Discussed their comfort level as well as setting rules/boundaries with the children so on one gets hurt. Discussed the children climbing over the cement blocks in fenced in play area and educators were observed instructing the children how to do it safely.

Discussed with educators plans to change the outside play area and ideas were shared of the vision. An application for changes will be sent to the operator. Great to see the updates to the inside of the facility with new paint, shelving, toys, mats etc. It is warm and inviting and many interest centres set up for the children to interact and engage with.

Discussed with the educators the Parent Portal where the most up-to-date information regarding the Recovery Phase document can be found and the link was shared with the educators.
