| <p>During the follow up to the renewal inspection it was noted that the environments were not purposefully planned, child-lead, or having defined interest centres, A monitoring inspection was generated to address these non-compliances.</p> <p>Discussed with Operator, Administrator and Educators the importance of having defined interest centres, webs and documentation. Children being able to engage in age-appropriate learning, based on their interests. Also discussed napping children and those who do not nap, having quite activities available for them to interact and engage in with their educators while children rest/nap.</p> <p>Recommending the Operator, Administrator and Educators refer to the New Brunswick Curriculum Framework-English, Curriculum Support Documents, CAT, CAT-RG, Operators Manual for Full-time and Part-time Early learning and Childcare Centres for support in setting up engaging and inviting learning environments for the children in their care.</p> |
