Comments: The outdoor play area was lacking in materials. A conversation was had with operator and educators, and there are plans in place to purchase new summer toys and activities.							
Some recommendations are as follows: Bubbles, Tetherball, Balance Bikes, Metal Tonka Trucks, more Risky Play Activities, real materials and supplies for the Mud Kitchen (real frying pans, muffin tins, utensils, etc.) Toys and activities should match the interests of the children.

Comments: The lock on the basement door was unlocked. This door is to be locked, at all times.							

## **General Comments**

A Monitoring Inspection was conducted this morning. Children were observed during snack, inside play, during the transition to outside, and during outside play. The preschool room was set up with several well-defined learning / play centers. These centers were well stocked with materials and accessories. The cozy reading corner had a tent, big stuffed animals, a big rug, a family wall, full of family pictures, and several books. Other areas that were observed included a building center, science center, an arts and crafts center, and a dramatic play center, which included a flower shop. Several forms of documentation were observed - learning stories, photos, children's artwork, etc. Positive child guidance techniques were observed. Educators were observed praising the children for their creations, for their listening skills, and for potty training successes. The outdoor play area was lacking in materials. A conversation was had with operator, and there is a plan in place, to add some materials and activities to this area. There were also some outdoor items that required repairs / replacements, and operator has stated that a plan is also in place to get these items repaired / replaced.
