General Comments

A Monitoring Inspection took place on November 8, 2024.

During the inspection, children were observed participating in indoor free play and transitioning to snack time. Proper handwashing procedures were followed during the transition to snack, ensuring hygiene standards were met. Additionally, steps or platforms were provided to help children reach regular-sized toilets and sinks, supporting their independence and safety.

Educators shared that the children are currently very interested in weekly dance parties with glow lights, reading books with their educators, and having free art opportunities. The educators are actively involved in the children's activities, providing support and guidance during play, learning, and creative moments.

The facility maintains a daily incident log, which is up to date and well-managed. Parents of children attending the center are granted entry at any time, ensuring transparency and open communication. Outdoor play is scheduled for at least one hour in each four-hour block of time, weather permitting, and is enjoyed by the majority of children attending. Monthly emergency evacuation drills are carried out.

All nap equipment in the facility meets safety standards, with a thickness of at least 5 cm. Snacks are provided at intervals of at least three hours, while meals are served during recognized meal periods. The daily routine is posted in each room for easy reference, and the weekly menu, including any substitutions, is also displayed. Emergency evacuation procedures and life-threatening allergy information are posted prominently throughout the facility.

The facility is well-equipped with a variety of appropriate materials, books, toys, and equipment. Toxic products, such as chemical cleaners, are securely locked and inaccessible to the children. The changing area is located no more than one meter from a sink, and diaper changing procedures are clearly posted and visible to those performing the task. Drinking water is readily available throughout the day, and the infant outdoor play area is either separate or used at different times from the other children's play areas, ensuring safety and appropriate supervision.

General Comments

A conversation was held with the Operator regarding the strengths and needs of the facility. The strengths highlighted include the purposeful planning and documentation of daily activities, as well as the opportunity for both individual and group experiences. However, some needs were also identified during the conversation. These included ensuring that children's artwork is labeled with the child's name and date, making art materials and books more accessible and rotated in all rooms, and ensuring that materials are appropriate for the ages and developmental stages of the children.
