<p>General Comments</p> <p>A Monitoring Inspection occurred February 5, 2025.</p> <p>Children were observed engaging in indoor free play, exploring various activities that encourage creativity, problem-solving, and social interaction.</p> <p>Educators noted that children are currently very interested in STEM activities, such as building popsicle stick bridges, making homemade playdough, painting with unconventional materials, creating a monthly collage of pictures, and exploring sea animals in a sensory bin. Educators actively discuss ideas with children, asking questions and expanding on their ideas to support engagement and learning.</p> <p>The facility maintains a daily incident log, and the daily routine is posted in each room. Evacuation procedures are clearly posted in a prominent location, and life-threatening allergies are documented and displayed as required. Parents and children are greeted warmly upon arrival, fostering a welcoming environment. Books have been thoughtfully selected to reflect the children's interests, and well-defined learning and play areas were observed. Children's artwork is displayed throughout the facility, highlighting their creativity and achievements.</p> <p>A sensory area is available with sufficient materials, such as sand and water, with accessories that are provided and rotated regularly. Traffic areas are kept clean, and outdoor walkways are free of clutter. Toxic products, including chemical cleaners, are securely locked and inaccessible to children. The changing area is located within a meter of a sink, and diaper-changing procedures are posted and visible to those performing changes. Drinking water is provided throughout the day to ensure children remain hydrated.</p> <p>The curriculum includes various forms of literacy within the indoor environment. Children have opportunities to express creativity, explore the arts and sciences, experience accomplishments, engage in problem-solving, and develop trusting, respectful, and supportive relationships.</p>
