<p>A renewal inspection occurred today. Educators were observed during morning meeting, lunch and rest/quiet time. Children were offered play both indoors/outdoors. Handwashing was observed. Art areas were well stocked with a variety of materials. A nutritious lunch of Beef Stew was served and it was observed the children being able to ask for seconds and being served second helpings.</p> <p>Educators were observed in the 3/4 year old room down on the floor actively engage with the children in songs. The use of props and finger puppets were used to enhance the songs being sung by the children.</p> <p>In the 2/3 Year old room, Tuff Trays are being used to support the children's learning. Currently, the children's interest is the "Three Little Pigs" and the Educator has used the Tuff Tray to create sensory activities for the children.</p> <p>Educators were observed having respectful and meaningful conversations with the children and tending to their needs.</p>
