<p><b>General Comments</b></p> <p>A monitoring inspection occurred in the afternoon.</p> <p>The children were observed in both the indoor and outdoor environments including transition between the two. Additionally, the children were observed arriving from school with handwashing occurring before the children transitioned to their groups.</p> <p>K-One Room: The children were observed filling their water bottles and transitioning outdoors. Educators indicated that the children are currently interested in Beyblades, computer activities, and outdoor play.</p> <p>Planetarium Room: The children were observed engaged in a variety of indoor activities that included playing with Beyblades, reading books, and eating snack, with handwashing occurring beforehand. Educators indicated that the children are currently interested in dramatic play, Barbies, small animal figures, Beyblades, and blocks.</p> <p>½ Gymnasium – This space was not required today due to low attendance.</p> <p>Both groups were observed outdoors engaged in a variety of activities that included using the playground structure, swinging on the swings, playing basketball, using Beyblades in a tuff tray, and digging in the dirt.</p> <p>Several forms of documentation were visible throughout all rooms, including photographs, and children's artwork. The rooms were well organized and inviting, offering a varied supply of age-appropriate materials, books, and toys.</p> <p>A clearly visible and prominent area was designated for the posting of the facility license, current monitoring reports, and any orders for compliance. Additional documentation reviewed included incident logs, daily attendance records, two staff files, and records of evacuation and monthly fire drills.</p>
