Comments: Toxic product on shelf in storage closet and paint in unlocked storage area in dungeon room. Products were removed and locked during monitoring inspection. Deficiency is now compliant.			

<p>General Comments</p> <p>Educators and children observed in a variety of activities throughout all rooms during today's monitoring inspection. Educators were observed to speak kindly and appropriately to children and used positive child guidance techniques when needed. A balance of indoor and outdoor activities were provided for the children.</p> <p>To ensure purposeful planning is documented, it is recommended that educators be provided with a binder for each group where they can add their daily or weekly planning.</p> <p>Discussed enhancing environments for older groups of children to ensure they are reflective of their interests and abilities. As well as ensuring materials are displayed in a way that is inviting for the children. Having invitations set up with materials that are age appropriate and reflective of children's interests before they</p>

arrive to the club after school can provide a smooth transition and engage them in activities that they will find meaningful. Invitations can also give children opportunities to revisit their work, add complex ideas, extend ideas, and/or try new skills.
