Educators can add the children's words to their creations and display them for the children to revisit.</p> <p>Recommend assigning the responsibility of ensuring open ended art materials are replenished throughout the day to a staff member as depleted art materials has been a compliance issue on the last few inspections.</p> <p>Preschool room (side by the kitchen) art shelf and block shelf to be switched as it was observed today that the art shelf was in front of the rug area where the children bring the blocks and vehicles to play making the art shelf</p>
