Comments: Preschool Outdoor Play Area: Some wood pallets starting to split and splinter. To be removed and replaced. Discussed with staff that pallets may be used however, daily checks for damage must be conducted and damaged pallets must be discarded. Black Little Tikes Truck - bolt protruding from back and tires in poor repair. The truck has been filled with rocks and no longer can be moved. Truck must be removed from outdoor play area and discarded. QA Monitor discussed with staff during inspection.

Children and educators observed engaged in a variety of activities this morning. All groups spent most of the morning outdoors exploring materials in the outdoor play area. A variety of loose parts have been added to the outdoor play area to encourage children to build and explore healthy risks.

Each indoor play area is set up with a variety of materials. Documentation is displayed within each environment that supports the children's current interests (climbing, cooking, mud, forts, robots, obstacle courses, bubbles, tape and chalk). Connections to the NB Curriculum and to home are included in documentation.

Banana pancakes and sausages were served for lunch.

Hand washing routines observed.

Diaper changing procedures observed to be followed.
