General Comments

A renewal inspection occurred today, July 23, 2025.

Upon arrival at the childcare facility, Inspector observed the 3/4-year-old group of children gathered, with their educators, under a tree singing songs, the 2/3-year-olds were observed walking to the fenced in play area with their educators, and the infants were preparing to make muffins with their educators.

All staff files and operator files were reviewed and verified complete. A random review of twenty (20) children's files occurred and were verified complete.

Discussed the outside play area and shade in the infant outside play space. A top for the gazebo is installed and removed daily by the educators due to wind in the play area's location.

Discussed with the Educators to ensure that the children have access to their water bottles during outside play and recommended that the educators bring them outside.

Positive child guidance was observed by the Inspector during the renewal inspection. Educators were also observed engaged with the children in their learning and play.
