Children were observed to be turned away from the block centre by their educator as there were "too many children (4) playing with the cars and blocks". Daily activities must allow children the time and place for free choice play experiences. Programming is to be flexible to incorporate the interests of the children and allow for spontaneous activities.

## **General Comments**

Monitoring Inspection:

Preschool Room:

Children engaged in story time and play this afternoon. Educator has set up a variety of invitations at each table. Photos of the children's families are hung in frames throughout the learning environment. Nice touch! Children have created a large floor size map of their neighborhood for their cars and trucks. The children in this group are currently interested in vehicles and roads. During the inspection today educators were observed to be limiting the amount of children permitted to play with these items. When there is a growing interest within the group this is an opportunity to expand the block and vehicle area to allow more children to engage in play and exploration. Children must not be excluded from playing with their peers because of a limited number of children permitted within one interest centre. Discussed with operator today.

School-age Room:

Children engaged in outdoor play this afternoon. The children in this group are currently interested in catching bugs. What materials could you add to the outdoor play area to expand on this interest?

Discussed with educator creating a more inviting art area. Open ended art materials to be displayed in way that invites children to get creative.

Hand washing routines observed today.
