Comments: Toxic products stored in high cupboard in kitchen unlocked. Toxic cleaner stored on high shelf in upstairs bathroom inaccessible to the children but unlocked. These products must be locked by either a CSA-approved child safety lock product or by lock and key.			

<p>General Comments</p> <p>Educators were observed to engage with the children in a positive way in each bubble group. The children were happily playing with toys and materials in the interest centers and freely circulating their learning environments. Educators were very responsive to the children's needs and interacted with the children at their level. Topics of interest are being explored and evidence of the children's learning is visible. Each room has a binder that is being maintained with documentation and connections are being made to the NB Curriculum Framework.</p> <p>Observed frequent handwashing, well-established routines for meeting COVID-19 protocols, and a balance of indoor and outdoor play.</p> <p>Be sure to use the correct form when Tylenol is given to a child (Appendix 8-Administration of Acetaminophen Record).</p> <p>A fire drill has not yet been completed for this month; therefore, a drill must be completed before end of day on Monday, August 31.</p> <p>A new Certificate of Insurance is required upon expiry of the current certificate (September 5, 2020). Please send a copy to your Early Learning and Childcare Inspector once received.</p> <p>This facility meets the qualifications and training requirements as per Licensing Regulation 11(c)(ii) (A) at least 50% of educators must hold a one year Early Childhood Education Certificate or training that is equivalent, and (B) an administrator must hold a one year Early Childhood Education Certificate or training that is equivalent.</p>
