Invitations include questions as provocations for children. Materials are accessible for children and allow free choice and movement throughout the rooms. Current interest topics are brought alive in the environment to encourage further exploration of the topics. Addition of new materials and books have been a highlight for the children.</p> <p>In the outdoor environment, a variety of materials are provided including materials from indoors. Children were observed engaging with books and mark making with crayons in addition to bubbles, sand play and cars.</p> <p>Documentation binders in each room allow educators and children to highlight recent learning and provide opportunities to revisit past experiences.</p> <p>Ensure the year is added to the date on daily incident logs.</p> |
