Block area--green rug, edges frayed.

Comments:     Preschool Room: Wicker bin in block centre broken. To be discarded. Dress-up display accumulating dirt and debris, to be cleaned.  After School Room: Dramatic play kitchen sink accumulating dirt and debris, to be cleaned. Art bins accumulating dirt and debris to be cleaned.			

General Comments

A renewal inspection was conducted today on both the preschool and afterschool rooms.

In the preschool room educators observed very engaged with the children in their learning and conversations. A display board has been created with the children's pictures depicting each step in putting on outside winter wear. Children were observed making reference to the pictures to ensure they were putting on all appropriate outside wear for playing in the snow.

After school room was set up with interest centres prior to the children's arrival with play-dough, art, games and snack. Children have the ability to pick which activities they wish to participate in. Educators observed speaking appropriately to the children and engaged in their learning.

Outside play was observed in the preschool in the morning, however in the afternoon no outside play observed due to weather conditions. Children in the afterschool program had the choice of participating in gym activities with the educator or remaining in the learning environment with an educator to participate in activities there.
