General Comments

Completed renewal inspection today.

Hand washing routines were observed numerous times throughout the inspection today. Children did not participate in outdoor play this afternoon due to the rain.

Some improvements were noted with respect to purposeful planning within the MacMurray room today. Invitations were set up for the children's arrival within both groups. The children were observed to be engaged in chess games, balloon decorating, open ended art.

Children within the Victor Leaman room were observed enjoying board games, cards, exploring the dramatic play area (doll house) and the creative art center but additional effort in purposeful planning is still required. The children's interests should be easily identifiable within each room.

The creative art center within the Victor Leaman room was well organized with a variety of materials accessible to the children. Some of the children were eager to share their origami creations today. Other children expressed their interest in Minecraft and were observed incorporating this into their art. What could be added to the environment to support this?

Allergies posted on board within the MacMurray room to be updated as some children are no longer within the program.

The importance of educators modeling health and well being when caring for children was discussed with on site supervisor at the time of inspection. Pop cans, chips and take out food observed within program rooms today. This was previously addressed and discussed at a recent monitoring inspection (January 19, 2021).

The educators were observed to be engaged with the children throughout today's inspection, speaking to them in a respectful and nurturing manner. The children were also noted to be kind and respectful towards each other.
