<p><b>General Comments</b></p> <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this afternoon including art, dramatic play, outdoor play and gross motor games. Group One was observed during gym and snack time. Group Two was exploring their indoor play area; a small group of children were hanging out in the cozy area, and another group were painting canvas. Group Three was observed exploring the wooded area behind the building; educators stated that they conduct daily sweeps of the area before children explore.</p> <p>Parent Board - the most current Monitoring Inspection report is not posted. Ensure new Monitoring Inspection report is posted. Menu indicator to be added to show which weekly menu is currently being served.</p> <p>During transitions, educators were observed conducting frequent headcounts to ensure that all children were present and accounted for.</p> <p>Pitas and carrots were served for snack.            Handwashing routines were observed after outdoor play and before mealtimes.            Monthly fire drills are documented.            Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection.            New staff file (4) review was completed; all required documents are in place.</p>
