Order for Compliance Regulation Date corrected Date to be corrected Comments: Threes Room (both sides) and Fours Room (both sides): Art materials depleted. Markers without covers, scarp paper only accessible, collage materials depleted, paint, paper and paint brushes not accessible at easel, chalk not accessible at chalkboards. Examples of open ended art materials to be added: paint, paintbrushes, white paper (full size pieces to go with half sizes), cardstock, construction paper, glue, collage materials, paper towel tubes, items from nature, chalk, markers, pencils, etc. Threes Room: Side 1 (far side): Dramatic play materials depleted. A few dishes and pieces of play food, one hat, two dolls and doll blanket were observed in the dramatic play area today. Table and chairs not included in pretend kitchen area. Dolls without clothes. Examples of items to be added to dramatic play area: doll bed, doll clothes, hard hats, tools, play food, pots and pans, dishes, wooden spoons, skirts, vests, purses, menus, pad of paper, etc. Threes Room: Side 2 (side with sink): Dramatic play materials depleted in pretend kitchen today. Table and chairs not included in pretend kitchen area. Doll house without furniture or people. Dolls without clothes. Ensure that accessories are included with these dramatic play items. (example: doll clothes on dolls, furniture and people in doll house, dishes and food with pretend kitchen) 32(1) An operator of a licensed facility shall provide indoor play area 32(1)(d) Nov 16, 2020 materials and equipment that are (d) clean and in good repair. This was brought to educators Comments: attention during inspection; was immediately resolved. Household paint and aerosol snow spray paint unlocked in cupboard under sink in threes room. This was

brought to educators attention during inspection; educator stated that lock is broken. Lock must be repaired and/or toxic products removed.

39(2) A licensed facility shall have a separate locked storage space that 39(2)(b) Nov 11, 2020 is inaccessible to the children for each of the following: (b) medications.

Comments: Ibuprofen unlocked in cupboard in threes room.

This was brought to educators attention during inspection; was immediately resolved.

General Comments

Fours Room - Side 1 (window side):

Children engaged in play this morning. Children in this group are interested in transportation. Educator has added a variety of vehicles, road signs and photos of types of vehicles to the environment. Children observed playing Hide and Seek with the cars. Discussed with educator how Hide and Seek could be another interest she could incorporate into the environment to go along with transportation.

Fours Room - Side 2 (side with sink):

Children in this group were out for a walk this morning.

This group of children have a growing interest in space. Educator has added materials to the learning environment that engage and expand on this interest including space boots, a rocket ship, planets, stars and

books about space. An invitation had been previously set up asking the children to draw what they thought an alien looked like; their drawings are now displayed on the wall with the question. This is a great way to make children's learning visible in the room!

Fours Room:

Ensure documentation is posted for the children on their side of the room as today it was observed that most of the documentation for the children from Side 2 (side with sink) was all on Side 1 (window side). This will allow the children of each group to revisit what they have done.

Threes Room:

This room is in need of some support as materials are depleted, documentation is not current and purposeful planning is not evident. Photos of the children, open ended art displays and invitations to be added to these environments that expand on the children's interests and learning.

Recommend educators review pages 6-8 of the NB Curriculum Framework - Collaborative Assessment Tool (CAT) .

Open ended art areas can now be added back into each group. Children can share art materials within their group. Ensure markers, scissors, glue and pencils are included in the sanitizing twice daily.

Discussed Group Logs with educators today. Group Logs should list all children in that group everyday even if the child is absent for the day. A note can be made next to child's name when they are absent. First and last names of staff and children must be included on Group Log. Recommend filling out Group Log with names and date established then photocopying for the week to save educators time throughout the day.
