Children and educators observed engaged in variety of activities this morning including outdoor play, music and

movement, block building, open-ended art and sensory opportunities. A group of children were observed exploring homemade playdough and making "pizzas" for their peers. Materials were set-up to encourage children to explore cutting and creating with the playdough.

An inspection of the outdoor play area was conducted this afternoon. The outdoor play area is set-up with a variety of materials for the children to explore. Educators were observed conducting minor repairs to some of the larger pieces of equipment during inspection.

Handwashing routines observed at arrival, after outdoor play and before mealtimes.

Chicken nuggets with sweet and sour sauce, rice and mixed vegetables were served for lunch. A halal option of the chicken nuggets was also available to children. Trail mix, apples and cheese were served for afternoon snack.

A monthly fire drill was conducted during inspection. All children and staff were evacuated to a meeting place at the far end of the parking lot. Educators were observed taking attendance and a head count before re-entering the building.
