<p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities both indoors and outdoors this afternoon. Activities include building, open-ended art, fine motor activities, digging and dumping, and gross motor play.</p> <p>Each indoor play area is set-up with a variety of invitations for the children to explore freely. Purposeful planning is evident through documentation on the planning sheets and through invitations. Educators are currently doing activities to get to know the children as, they have just started in their new rooms this week.</p> <p>Monthly fire drills are documented.</p> <p>Daily attendance records are accurate and reflect all children present.</p> <p>Child-to-staff ratio was observed to be met during Monitoring Inspection.</p> <p>New staff file (2) review was completed, all required documents are in place.</p> <p>Handwashing routines observed after outdoor play and during washroom routines.</p>
