General Comments
<p>A renewal inspection occurred today. During the visit, the 3/4-year-old room was observed with children's artwork displayed, including snowmen created with glued tissue paper. The children were engaged in tabletop activities as they transitioned to lunch, using trucks and laminated tracks while they waited. Sensory bins were filled with rice and coloured noodles to reflect the season, along with measuring cups and bowls for digging.</p> <p>The art area offered paper, glue, scissors, and shape cutouts. Clear bins were labelled and placed at the children's level, containing materials such as Magna-Tiles, gears, fidgets, interlocking stars, and bristle blocks. Educators had a designated drying space for artwork, labelled with each child's name and photo so children could independently place their creations to dry.</p> <p>Current interests in this room included a "grocery theme," and documentation reflected this, showing items the children had cut out from flyers featuring things on sale. Books were accessible in the reading and quiet area. Handwashing was observed as children entered from the outdoor space.</p> <p>In the 4-year-old room, magnetic blocks were set up at the children's level for easy access. The room's theme was "hot chocolate," and educators had created a pretend hot chocolate stand with cups and materials for serving. Documentation on the walls reflected the children's interests, including "pretend hair salon" and "snip, spray, style." Sensory bins were set up with felt, buttons, magnetic bells, and wrapping paper to reflect the Christmas season.</p> <p>Lunch today consisted of milk, meatballs, potatoes, and corn. All allergies were clearly posted with children's photos and names.</p> <p>The outdoor area was also observed. Children were playing in the teepee, driving trucks, and digging in the sand. An educator brought out a book of interest titled Dinosaur Christmas to share with the group. Headcounts were completed twice before re-entering the building, once before leaving the playground, once at the door, and again upon arrival in the classroom.</p> <p>All staff files were reviewed and complete. A random review of children's files was also conducted, and these were complete as well. Fire drills were posted and up to date.</p>
