Areas that are lacking include dramatic play, science/investigative materials, Lego, games, books and art supplies. Provided ideas regarding art caddies or containers for each child to store their art supplies in to reduce contact with all materials. Also discussed additional ideas with educators regarding topics of interest and items that could be added to each space (ex: solo cups for building, materials to support a hair salon/vet center).

The cash register within the play kitchen was unclean today as well-to be cleaned/sanitized. There was also a container missing from the kitchen where the sink should be-to be replaced.				

## **General Comments**

Monitoring inspection-COVID-19 Recovery Phase.

Screening procedures were implemented upon arrival. Facility has a contact ear thermometer on site to be used for mid day checks and are sanitizing the thermometer between uses. Mid day checks were completed within the K/1 group during inspection today.

Group logs are being completed. The children entered the building after their outdoor time during today's inspection. Hand washing and lunch routine were both observed today.

Program was planned for the week. Children were engaged with clay molding today within the "Ultimate building challenge camp." There were also some painted rocks, and soap sculptures observed on the window sill and collages within the other room. Discussed some other ideas that were planned for this week with educator. It would be nice to see additional documentation displayed around the room, demonstrating the children's interests and creations. One educator stated that a few current topics of interest include: hair salons and animal/vet topics. What could be added to the children's space to support and expand on these topics? Photos of the children engaged in activities would also be a great way to document the children's learning (as suggested in the last monitoring inspection). The last monitoring inspection also recommended setting up invitations for the children, but this was not observed today.

Discussed the need to add more materials within both groups with on site supervisor.
