## **General Comments**

Monitoring Inspection to follow up on orders for compliance ahead of Renewal Inspection.

Improvements have been noted within the Mini Gym environment. Materials are becoming more organized, and shelving is arranged in a way that creates interest centres.

Dramatic play materials have been added however they are stored within the cozy/reading area. It is recommended that these materials each have a designated interest centre, this will help avoid the noisier activities interrupting the activities that are quiet.

New board games and puzzles have been added to the environment. Ensure board games that are in poor

repair are removed. QA Monitor recommended adding a jar to keep extra game pieces in, this allows children to look in the jar when pieces of the games go missing or allows them to create their own board games with the collected pieces.

First Aid supplies have been depleted, and emergency contacts are not accessible to staff. Supplies to be replenished and contacts to be added. QA Monitor discussed with administrator during inspection.
