Comments: One of the five audited child files has incomplete addresses for the emergency contacts. The Administrator added the missing information. Deficiency is now compliant.

Comments: The kitchen door has a child proof door knob cover and a baby gate that can be opened by some children. The Administrator must take steps to ensure that the kitchen is inaccessible when not being used by staff.
