time. When children are napping, staff members included in the child-to-staff ratio who are on break must								
remain on-site and must be easily accessible within the building. A staff member was immediately placed in								
the room to respect the child-to-staff ratio upon being made aware that the ratio was not respected.  Deficiency is now compliant.
