33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Aug 25, 2023	
Comments: The protective surfacing for the swing set was not of an appropriate depth allowing the play structure to easily move and is not safe for children to play on. Stationary equipment should be surrounded by a protective surfacing of an appropriate depth (30CM). QAM advised the administrator that children are not to play on the structure until they add the appropriate depth for the surfacing and the swing set are no longer able to easily move. Administrator advised the QAM that the swings will be removed and the children will not be allowed on the structure until it is safe.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Aug 22, 2023	
Comments: 15 bottles of water weren't labelled with the child's name. All personal belonging should be labelled with the child's name. Cubbies being used by children were not labelled with the child's name. Every cubby being used should be labelled with the child's name.

QAM verified: - Posted in a visible and prominent place in the facility. -Indoor play area materials and equipment  While on site QAM observed preschool children playing outside and the school-age children were having a scavenger hunt through the village. QAM was also able to observe lunch time and transition to nap time for the preschool children.
