Comments: There are currently modifications being made in one of the outdoor play areas (a walkway is being put in). In the other play area, there is a gravel pile with orange cones around it as well as a rusty wheelbarrow. Administrator may use the outdoor play area that is not currently under construction. However, Administrator must ensure that the wheelbarrow is removed before the children go outside. Administrator must also ensure that there is adequate supervision to ensure that children do not go near the pile of gravel. Children are not to use the outdoor play area that is under construction, until this has been completed. Administrator will advised the Inspector once construction is completed.

Comments: One of the diaper changing areas is not located less than one meter from a sink. Administrator must ensure that the area is either moved to a location in which it is less than one meter from the sink, or remove the changing area and use one that is located less than 1 meter from a sink.
