Inspector observed the educators allowing the children to freely choose the activities in which they were interested. Some children chose to paint, others chose to dress up, some chose to play with blocks, and some chose to play with Play-Doh.

Inspector observed positive interactions between the educators and the children, such as setting reasonable limits that make sense to the children, gentle reminders, as well as celebrating with children during moments of success.
