Comments: While verifying staff members file, the Quality Assurance Monitor observed that one staff file was missing the copy of a valid first aid certification. The certificate was posted in the posting area but not inserted in the staffs file. Each staff file must contain a copy of the Valid first aid and CPR certificate. A copy was inserted in the staffs file. Deficiency is now compliant

Comments: While verifying the attendance records, the Quality Assurance Monitor observed that 2 children were not marked in. The attendance records must be completed each time a child arrives and leaves and must be accurate and reflect all children present at any given time. The operator immediately signed in the children. Deficiency is now compliant.			

General Comments
<p>The Quality Assurance Monitor is on site for the renewal inspection. The ratio was respected during the inspection.</p> <p>The QAM had a discussion with the operator regarding child consent left blank in the childs file. The consent for the school transportation and walking from school was left blank. The QAM asked the operator to get the parents to fill it out as not applicable since this does not apply to the preschool childrens.</p> <p>The children were observed finishing eating their snack and playing in the indoor area. The children were also observed transitioning to the outdoor play area. The operator had an application on her phone that indicated what kind of bird the children were hearing outside. The children were able to look at a photo of the bird and associate it with the sound they were hearing. The children were digging for rocks and worms while playing outside. The QAM observed the children transitioning for lunch time and then nap.</p> <p>Positive interactions were observed between the operator and the children.</p>
