Comments: While verifying a new staff member's file, the Quality Assurance Monitor observed that the staff member had a Adult-Child-Infant CPR AED Standard First Aid (Level C) from Healthsaver. The Quality Assurance Monitor asked the administrator if they have verified that this is an equivalent to the Workplace Standard First Aid Level C that is required. The administrator confirmed that they had not verified but that they would look into registering this staff member to redo their First Aid Certification as the whole staff members have booked a training class. The Quality Assurance Monitor has advised that the staff member cannot be left alone with a group of children until they have either confirmed that this certification is an equivalence or if they have received a valid First Aid Certification. A copy must be placed in the staff file.

## **General Comments**

The Quality Assurance Monitor is on site for a monitoring inspection. The Quality Assurance Monitor is on site during lunch time and nap time.

The ratio was respected at all times during the inspection and the Quality Assurance Monitor was able to observe an educator being attentive to a child's need and respected their needs and comfort. Once the child had regulated, the educator remained attentive to the child and stayed close to the child while still supervising and guiding the other children during a transitional moment.

The Quality Assurance Monitor was able to confirm that the medications were locked and made inaccessible to the children during the inspection. The administrator has confirmed that medications used for anaphylactic shock is stored safely but easily accessible to the educators. The administrator has confirmed that only the child's parents can provide medication, with the exception of acetaminophen. Medication that is non-prescribed are only accepted if they are in the original child safe container with the original label and labelled with the child's name and dosage. The administrator confirms that when they receive prescribed medication, that the medication is also labelled with the doctor's name, instructions for use, and the time period for use.

The administrator has confirmed that parents must notify them of their child's absence and must indicate if the absence is due to illness or other reasons. The administrator confirmed that if a child becomes ill while they are at the facility that they are separated from the other children to be provided with care until someone is able to pick up the child, within one hour of notification of illness. The administrator validated that children are provided with medical assistance is required and that the management of potential illness forms are completed as required. The administrator confirmed that the parents are advised when a child has a communicable disease or illness.

The administrator was able to show that the administration of medical records are evident and has validated that parent provide written or oral permission to give acetaminophen. The administrator confirmed that when parents provide oral permission to give acetaminophen, a written confirmation is given when they pick up their child. The administrator has confirmed that the administration of medication records are kept for each child as indicated in regulation 24(3).

The Quality Assurance Monitor was able to observe easily accessible space provided for each child's personal belonging. The Quality Assurance Monitor also observed that the personal belongings were labelled with the name of the child and that they were stored separately for each child. The administrator validated that the personal belongings are only used for the intended child.
